

**District of Columbia Bar
Board of Governors Meeting
April 12, 2022**

**Call to Order

President's Report (Agenda Item 2)

President Sarchio presented his report, highlighting a joint letter from him and President-Elect Jakovic to members of the D.C. Council in support of the Access to Justice Initiative. Thirty past presidents added their names in support of the letter. He noted the upcoming special membership meeting on April 27 where the members will be asked to vote on various resolutions and reported on the Bar's Spring Wellness fair which addressed issues of burnout and stress in the legal profession.

President Sarchio also noted that the Pro Bono Center's fundraising campaign is underway and encouraged all members of the Board to participate. He announced that he had named Judith Sandalow, Executive Director of the Children's Law Center, as the recipient of the Thurgood Marshall Award. He also announced Susan Pascoello, Senior Advisor at the U.S. Agency for International Development, as the recipient of the Beatrice Rosenberg Award for Excellence in Government Service.

President-Elect Jakovic provided an update on the ABA Bar Leadership Institute which took place in March in Chicago. Programming focused on bar governance, communication, and leadership.

D.C. Superior Court Chief Judge Anita Josey-Herring provided an update on court operations across all the divisions as well as anticipated vacancies on the bench. She shared that the "Reimagining the Courts" initiative has been vetted with all stakeholders over the last several months and is moving forward.
